1. Introduction

The European Commission (hereafter “the Commission”) is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reason for the processing of your personal data in the context of the event in title. It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to the processing operation in title, undertaken by the controller in title, is presented below.

2. Why and how do we process your personal data?

Purpose of the processing operation: the Data Controller collects and further processes your personal data to provide you with information about Science is Wonderful! 2021 (before, during and after) and to process your application for participation in that event.

Your personal data will not be used for any automated decision-making including profiling.

Live web-streaming and audio-visual recording at Science is Wonderful! 2021 of the speakers, organisers, researchers and participants, as well as photographs of the speakers, researchers and teachers, and panoramic photographs of participants and organisers will be taken and published in the context of Sciences is Wonderful! 2021 on the event landing page at <https://www.scienceiswonderful.eu> and the event platform at as well as on the general MSCA website managed by the European Commission at https://ec.europa.eu/research/mariecurieactions/node_en.

The audience or non-speaker participants are not photographed individually or in groups. They may however appear on panoramic photographs of the whole event/audience.

Profiles of speakers and researchers will be published on the event landing page; profile of these same people along with all the other visitors, specifically teachers and participating school staff, will be published on the event platform. Please note that this event will be held using third party videoconference IT services and platform, which process personal data. Please read Heading 7 below for more information.

Explicit consent from speakers and researchers will be sought and treated through a specific separate consent form whenever they appear on audiovisual recordings. Speakers and researchers will be contacted by the organisers to gather their consent.

3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the event in title are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular, Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union.

Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

The processing operations on personal data of the speakers for the event with whom a contract is concluded, are carried out in line with the contractual provisions. Consequently, that processing is necessary and lawful under Article 5(1)(c) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract).

Your consent is required for:

- the processing of your personal data relating to your access requirements;
- the sharing of your Science is Wonderful! participant profile and event attendees' list (containing as obligatory fields your first name, last name, gender, e-mail, country of nationality, city, languages spoken, organisation/institution/school full name, job/position/function within this organisation and as optional fields profile information (biography), picture, social media information) with other participants, in order to allow collaboration during the event and facilitate match-making, creation of working groups and pairs of researchers and schools, networking between participants and online talks with schools;
- for participating researchers, the sharing of your Science is Wonderful! participant profile and event attendees' list (containing as obligatory fields your first name, last name, academic title, e-mail, country of nationality, current country, languages spoken, organisation/institution full name and acronym, job/position/function within this organisation and as optional fields profile information (biography), picture, social media information, main research domain, references of your MSCA project) with other participants, in order to allow collaboration during the event and facilitate match-making, creation of working groups and pairs of researchers and schools, networking between participants and online talks with schools;
- the processing of your personal data for inviting you to future events the data controller may organise;
- the web-streaming and publication of photos and audio-visual recordings depicting you in an identifiable way.

For these issues you may give us your explicit consent under Article 5(1)(d) of Regulation (EU) 2018/1725 to process your personal data for those specific purposes. You can give your consent via a clear affirmative act by ticking the box on the online registration form.

You can withdraw your consent for these services at any time by contacting the controller for this meeting (see Heading 9).

4. Which personal data do we collect and further process?

The following personal data will be processed:

- the following contact details (containing as obligatory fields your first name, last name, gender, e-mail, country of nationality, city, languages spoken, organisation/institution/school full name, job/position/function within this organisation and as optional fields profile information (biography), picture, social media information) of speakers and participants, subject to the explicit and free consent from them;

- for participating researchers, the following contact details (containing as obligatory fields your first name, last name, academic title, e-mail, country of nationality, current country, languages spoken, organisation/institution full name and acronym, job/position/function within this organisation and as optional fields profile information (biography), picture, social media information, main research domain, references of your MSCA project), subject to the explicit and free consent from them;
- pictures, presentations, live webstreaming and/or audio and video recording of participants, researchers and speakers, subject to the explicit and free consent from them;
- profiles of participants, researchers and speakers, subject to the explicit and free consent from them.

5. How long do we keep your personal data?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing:

- All personal data related to the organisation and management of the meeting/event in title (this includes the information given during the registration, before, during or after the event) will be deleted **five years** after the last action in relation to that meeting/event.
- Recordings from the web-streamed meeting/event in title will be kept for **2 years** before being deleted. More information is available in the Record of Processing DPR-EC-00306 (Web-streaming of Commission events).
- Photos and videos for which consent was obtained through duly completed and signed Consent Form(s) for the meeting will be kept for **2 years**. Their publication in the following channels identified here above will follow the longevity of the content posted therein, unless consent was redrawn at an earlier stage.
- In case of audio-visual recording of the meeting/event in title, the recordings will be kept for **3 months** before being deleted. More information is available in the Record of Processing DPR-EC-01937 (Audio-visual recording of meetings).

Personal data shared with the controller for future mailing purposes (e.g invitations to similar events) are processed in line with the Record of Processing DPR-EC-03928 (Management of subscriptions to receive information) and the specific privacy statement prepared by the organising Commission service);

Selected service providers for organisational purposes (such as caterers, travel agents or event management organisations) are contractually bound to process personal data on behalf of and in line with the instructions of the data controller, keep confidential any data they process and protect it from unauthorised access, use and retention.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored either on the servers of the European Commission or of its contractors until the end of their retention period. All processing operations are carried out pursuant to [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

The Commission's processors (contractors) are bound by a specific contractual clause for any processing operations of your personal data on behalf of the Commission, and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - [Regulation \(EU\) 2016/679](#)). The processors have to put in place appropriate technical and organisational measures to ensure the level of security required by the Commission.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

Where necessary, we may also share your information with service providers for the purposes of organising the meeting/event in title:

Audio-visual recordings, photographs, presentations, names and contact details of researchers, speakers and teachers will be published based on consent from them.

Cookies

Cookies are short text files stored on a user's device (such as a computer, tablet or phone) by a website. Cookies are used for the technical functioning of a website (functional cookies) or for gathering statistics (analytical cookies).

Registration takes place via <https://www.scienceiswonderful.eu> which employs cookies as described on the websites.

The event will also be implemented via the Swapcard platform, which employs cookies according to the following policy: <https://www.swapcard.com/cookie-policy/>

Enabling these cookies is not strictly necessary for the website to work but it will provide you with a better browsing experience. You can delete or block these cookies, but if you do that, some features of the meeting/event website may not work as intended.

The cookie-related information is not used to identify data subjects personally. These cookies are not used for any purpose other than those described here.

Should you wish to opt your personal data out of our anonymised, aggregated statistics, you can do so on our cookies page. In particular, you can control and/or delete those cookies as you wish.

Third party IT tools, including Social Media *(if they are used, this will be explained in the specific privacy statement of the meeting or event)*

We may use third party IT tools to inform about and promote the meeting/event through widely used communication channels, including the social media. For detailed information about the use of social media by the European Commission, see the Record of Processing DPR-EC-00073 (Social Media Use by the European Commission).

You may be able to watch our videos, which may be also uploaded to one of our social media pages and follow links from our website to other relevant social media, such as Vimeo or YouTube.

In order to protect your privacy, our use of third party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or “play” on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

We recommend that users carefully read the relevant privacy policies of the social media tools used. These explain each company’s policy of personal data collection and further processing, their use of data, users' rights and the ways in which users can protect their privacy when using those services.

Please note that this event will be held using a third party videoconference IT service (Zoom) and a template-based virtual platform (SwapCard and Whereby). These IT tools have their own cookies ([SwapCard cookies policy](#); and privacy policies ([Swapcard Privacy Policy](#); [Whereby Privacy Policy](#)) over which the Commission has a limited or no control. 8. What are your rights and how can you exercise them?

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

The European Commission will ensure that the data subjects can exercise their right to object to processing whenever possible by the organisers of the meeting/event (for example, during the workshops, by advising not to turn-on the “active participation” mode; or ex-post, by deleting a specific sequence from the online video/voice recording).

If you consented to provide your personal data to the data controller for several processing operations, mentioned under Heading 3, you will be able to withdraw that consent at any time by notifying the data controller. Withdrawal of your consent will not affect the lawfulness of the processing carried out before the withdrawal occurred. You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below. The withdrawal of your consent will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.
